All prices are subject to change, please confirm with staff for confirmation.

Additional landing fees for landings conducted at airports that are not Moorabbin will incur a fee.

Air services fees may be applied to flights conducted through controlled airspace.

By signing the company authorization sheet the hiring party notes acceptance by the hirer of liability for payment of the price and acceptance of all applicable company terms and conditions of hire including those detailed in this document.

Unless expressly stipulated in writing the following hire rates, fees, terms and conditions are in addition to the terms and conditions as published from time to time and in force at the time of aircraft hire and are applicable to all BASE Aviation customers.

Refer to the company operations manual for abbreviations used.

Supervised Solo flight (defined as when an instructor is on the ground at the aerodrome where solo flight is being conducted by the instructor student or applicant and the instructor is responsible for the supervision of the solo flight) conducted as part of necessary hours accumulated towards the requirements of the initial issue or revalidation of a Pilot Licence, rating, design feature endorsement, flight activity endorsement or in the conduct of a flight review or solo night flight flying requirements (NVFR or IR) will be charged at the applicable rate with the instructors time added to the charge.

### **General Terms & Conditions**

#### *Fuel Purchases*

For wet hire, fuel purchased by the hirer, at other than Moorabbin Airport, will only be reimbursed at the applicable retail rate, payable by the company, per litre prevailing at Moorabbin at the time of hirer's purchase. Any differences in cost between the applicable Moorabbin rate and the actual cost paid by the hirer shall be borne by the hirer. Should the cost of fuel be less than the Moorabbin rate, no refunds will be given.

#### *Damage to aircraft*

Refer to the company terms and conditions of the hire, copies can be found in the designated aircraft folders. No forbearance, no waiver, or failure to enforce against the customer any term, condition or right arising under any training agreement. Company terms and conditions of hire or these fees and charges or a combination of them shall act as a waiver of any such term, conditions or right properly owing to or enforceable by the company. Nor will any single or partial exercise any right, power or remedy preclude any other or further exercise of that or any other right, power or remedy.

#### *Payment for Goods or Services*

Unless otherwise agreed in writing, all goods and services purchased from the company must be paid for on the day of such service or within the invoicing period.  
Any account not settled within the term will incur a \$20 account keeping fee and for each month or part thereof the account remains outstanding, a further \$20 fee shall apply.

#### *Interest on outstanding accounts*

Unless otherwise agreed in writing, all accounts outstanding may incur compounding interest calculated monthly at the Australian reserve bank cash rate (as applicable) +2%

#### *Recovery of costs incurred for debt collection*

Should BASE Aviation be forced to take debt recovery action any fees and charges howsoever incurred shall be recoverable from the debtor by the company and added to the original debt

#### *Surcharges apply to the following payment methods*

A 2% surcharge may be added for EFTPOS, credit card transactions.

#### *Reservation of rights*

The management of the company reserves the rights in relation to fees and charges and may at any time alter them without notice.
